INFO	4.06	The site has 77 existing parking spaces with the blacktop between buildings C and D used as interim parking/drop off areas during the school day.	N/A
INFO	4.07	The committee discussed the appropriate quantity of on-site parking. The recommended amount of parking for a school of this size is 124 spaces. The committee agreed that providing that much parking would eliminate much needed play space for the students. It was decided that providing 85 spaces would allow for the staff to park on-site and that visitor/volunteers would park off-site. These additional comments were made:	N/A
		 The committee asked to investigate street parking along Oak Knoll and/or eliminating part of the play field. Additional green space could be placed where the current parking lot is south of Building C. LPA will study this option for the next meeting. Drop off could occur in two locations – along Oak Knoll and in the new dedicated drop-off zone. This could be designated by grade level as part of the schools parking management plan. 	07.22.09
